An Appeal to Research Scholars

On 14th October 1956, Dr Babasaheb Ambedkar embraced Buddism along with his over seven hundred thousand followers at Nagpur and thus paved the way for the revival of Buddha's Dhamma in the land of its birth. Ever since the rise of Buddha on the religious firmament of the sub-continent, his message to humanity has been an 'unfading symbol of the ethical-rational as against bigoted – hypocritical in human relations'. The master clearly stood for those 'dimensions of thought that are rational, against priest craft, superstition, ritualism, all forms of religious oppression, for ethical uprightness, transparency in thought and behavior and compassion towards all, particularly the weak and the oppressed'.

Babasaheb too envisioned a life free from such evils which dwarf the ethical-rational behavior of human beings necessary for their advancement both material and spiritual. His conversion to Buddhism presupposed Buddhist religious ideology and symbolism to be the medium for achievement of lifeaspirations of the suppressed and their eventual achievement of human dignity and establishment of egalitarian society. The conversion was not an enticement to lure the stigmatized to overcome their centuries old disabilities alone. The purpose behind it was to reconstruct the world on the foundations of compassion, tolerance, reasonableness and morality which will awaken the men to engage themselves in life for achievement of material and ethical development fostering equality, fraternity and justice.

Now after more than five decades of conversion , the increasing flock of scholars and practitioners have begun to verify the tenets of Buddhism with a view to find reliable alternative to the otherwise prevalent dogmatic, ritualistic, sectarian, superstitious, divinely ordained beliefs and practices which are more collective - celebrational than ethical instrumental. Visualizing it impotent to bring changes in the life situation of human beings , in our case a victim of hierarchical and religiously given order, which is beset with ascriptive discrimination pushing them to ignorance, penury, stigmatization and suppression many of them are convinced that the Buddha's path is salvational and perfectionist.

Keeping in view these reverberations all around we think it opportune to invite the best brain like you to explore and construct a liberative, emancipatory theme which envisages a life of dignity and perfection to suppressed and oppressed.

For this purpose we have chosen the broad theme titled

"Ambedkar's Buddhism and its Emancipatory Potential."

Under which the following sub themes are -

1... Reinterpretation of Buddism in Ambedkarian Perspective.

2... A Practical View of Babasaheb's 'Buddha and His Dhamma'
